1 Fontos!

A termék használata előtt figyelmesen olvassa el az összes utasítást. A garancia nem terjed ki azokra a hibákra, amelyek az utasítások figyelmen kívül hagyása miatt keletkeztek.

Biztonság

Aramütés veszélye vagy tűzveszély!

- Mielőtt végrehajtja vagy megváltoztatja a csatlakoztatásokat, ellenőrizze, hogy minden készülék vezetékét kihúzta-e a fali aljzatból.
- Óvja a készüléket és tartozékait csapadéktól vagy egyéb folyadéktól. Soha ne helyezzen a készülék közelébe folyadékot tartalmazó edényt, például vázát. Ha a készülékre vagy a készülékbe folyadék kerülne, azonnal húzza ki az elektromos hálózati csatlakozót. Használat előtt vizsgálta meg a készüléket a vevőszolgálattal.
- Ne tegye ki a készüléket és tartozékait nyílt láng vagy hőforrás hatásának, például közvetlen napfénynek.
- Soha ne helyezzen tárgyakat a készülék szellőzőibe vagy egyéb nyílásaiba.
- Ha a hálózati csatlakozódugó vagy készülékcsatlakozó használatos megszaktúeszközként, akkor mindig működőképesnek kell lennie.
- Az elemeket és elemcsoomagokat óvja a magas hőmérséklettől, ezért ne tegye ki például közvetlen napfény hatásának, ne helyezze tűz közelébe stb.
- Villámlással járó vihar előtt húzza ki a készülék tápkábelét.
- A hálózati kábel eltávolításakor soha ne a kábelt, hanem a csatlakozódugót fogja.

Rövidzárlat veszélye vagy tűzveszély!

- A készülék azonosítóját és a tápellátás adatait a készülék hátoldalán található típusazonosító táblán találja.

- Mielőtt csatlakoztatná a készüléket a hálózati aljzathoz, győződjön meg róla, hogy a hálózati feszültség megfelel a készülék hátulján feltüntetett értéknek. Eltérő feszültségérték esetén soha ne csatlakoztassa a készüléket a hálózati aljzathoz.

Sérülésveszély vagy a készülék károsodásának veszélye!

- Falra szerelés esetén a rögzítési utasításoknak megfelelően, szilárdan rögzíteni kell a készüléket a falra. Kizárólag a mellékelt fali tartót használja (ha rendelkezésre áll). A nem megfelelő fali rögzítés balesetet, sérülést és kárt okozhat. Ha kérdése van, vegye fel a kapcsolatot az országában lévő vevőszolgálattal.
- Soha ne helyezze a készüléket vagy bármilyen más tárgyat a hálózati kábelekre vagy más elektromos berendezésre.
- Ha a készüléket 5 °C alatti hőmérsékleten szállítja, akkor a kicsomagolás után várjon, amíg a készülék hőmérséklete eléri a környezet hőmérsékletét, és csak ezután dugja be a tápkábelt a hálózati aljzatba.
- A termék egyes részei üvegből is készülhetnek. A sérülések és károk elkerülése érdekében óvatosan kezelje a készüléket.

Túlmelegedés veszélye!

- Ne helyezze a készüléket túl szűk helyre. A megfelelő szellőzés érdekében mindig hagyjon legalább 10 cm szabad helyet a készülék körül. Ellenőrizze, hogy függöny vagy egyéb tárgy ne takarja el a készülék szellőzőnyílásait.

Szennyeződésveszély!

- Ne keverje az elemeket (régi és új, vagy szén és alkáli stb.).
- Ha az elemeket rosszul helyezi be, felrobbanhatnak. Cserélni csak azonos vagy egyenértékű típussal szabad.
- Távolítsa el az elemeket, ha lemerültek, vagy ha hosszabb ideig nem fogja használni a távvezérlőt.

- Az elemek vegyi anyagokat tartalmaznak, így azokat használat után megfelelően kell kezelni.

Az elemek lenyelésének veszélye!

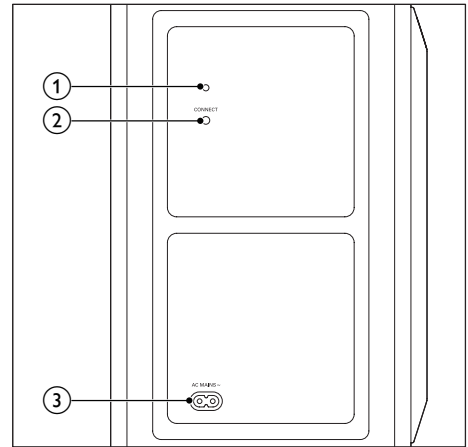

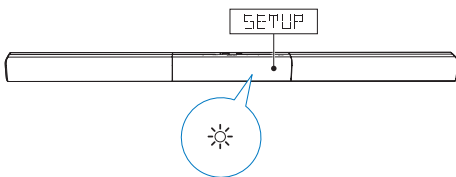

Figyelmeztetés hálózati beállításra

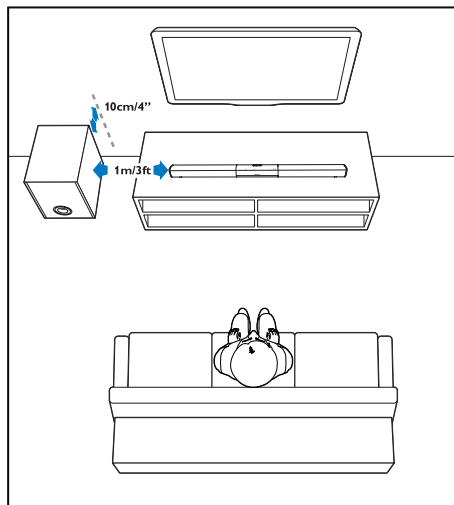

Elhelyezés

Helyezze a mélynyomót a főegységtől legalább 1 méter távolságra, valamint a faltól legalább 10 centiméternyire.

Párosítás a mélynyomóval

A vezeték nélküli mélynyomó automatikusan párba rendeződik a főegységgel vezeték nélküli csatlakoztatáshoz a két eszköz bekapcsolásakor. A fő egységgel való kézi párosításra van szükség, ha az alábbi esetek valamelyike fennáll.

- A fő egységből jövő hang nem hallható a mélynyomón keresztül.

 - ↳ Sikeres párosítás esetén a mélynyomó jelzőfénye fehéren világtani kezd.
 - ↳ Sikertelen párosítás esetén a mélynyomó jelzőfénye lassan, fehéren villog.
- 4 Ha nem sikerül a párosítás, ismételje meg a fenti lépéseket.

Megjegyzés

- Ha a vezeték nélküli lecsatlakoztatás vagy párosítás 1 percig tart, a mélynyomó automatikusan készenléti állapotba kerül, és kikapcsol a mélynyomón található LED.

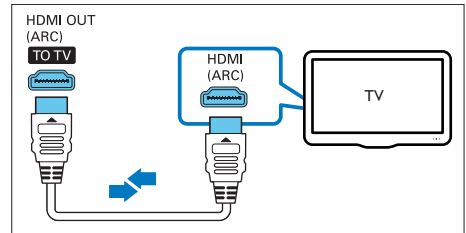
1. opció: Csatlakoztatás a TV-készülékhez HDMI (ARC) kapcsolattal

Kiváló minőségű audió

A készülék támogatja a HDMI Audio visszirányú csatorna (ARC) technológiát. Az ARC funkcióval a TV audiotartalmait egyetlen HDMI kábel segítségével hallhatja a terméken.

Amire szüksége lesz:

- Nagy átviteli sebességű HDMI-kábel.
- A TV-készülék támogatja mind a HDMI ARC, mind a HDMI-CEC funkciót (további részletekért lásd a TV-készülék felhasználói kézikönyvét).
- Bizonyos TV-modellek esetében engedélyezze a külső hangszugárzó kimenetet a TV-beállítás menüben (további részletekért lásd a TV-készülék felhasználói kézikönyvét).



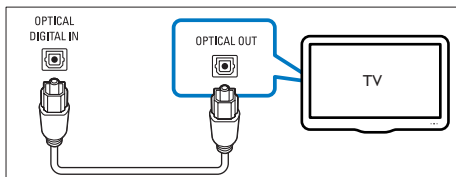

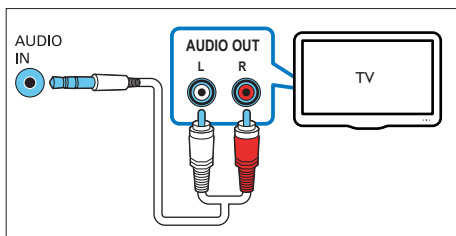

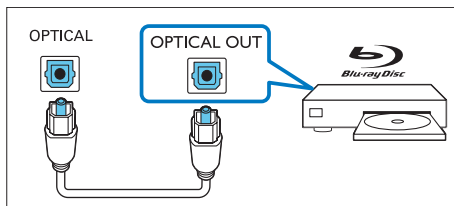

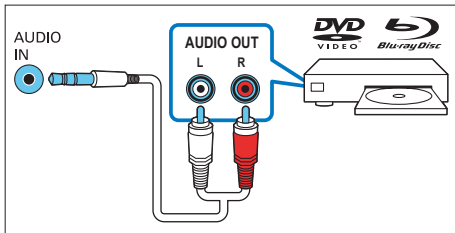

A hangerőszint beállítása

- 1 A hangerő növeléséhez vagy csökkentéséhez nyomja meg a **Hangerőszabályzó +/-** gombot.
 - A hang elnémításához nyomja meg a **🔇** gombot.
 - A hang visszakapcsolásához nyomja meg ismét a **🔇** gombot, vagy nyomja meg a **Hangerőszabályzó +/-** gombot.

Hang kiválasztása

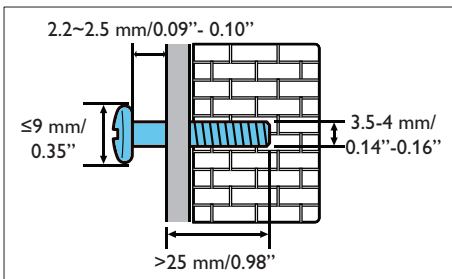

To protect each distributor, we want to make it very clear that there is no warranty for the free library. Also, if the library is modified by someone else and passed on, the recipients should know that what they have is not the original version, so that the original author's reputation will not be affected by problems that might be introduced by others.

Finally, software patents pose a constant threat to the existence of any free program. We wish to make sure that a company cannot effectively restrict the users of a free program by obtaining a restrictive license from a patent holder. Therefore, we insist that any patent license obtained for a version of the library must be consistent with the full freedom of use specified in this license.

Most GNU software, including some libraries, is covered by the ordinary GNU General Public License. This license, the GNU Lesser General Public License, applies to certain designated libraries, and is quite different from the ordinary General Public License. We use this license for certain libraries in order to permit linking those libraries into non-free programs.

When a program is linked with a library, whether statically or using a shared library, the combination of the two is legally speaking a combined work, a derivative of the original library. The ordinary
